I agree that by signing and dating below that I have read this waiver, that I am knowingly, voluntarily, and expressly waiving my rights, and that of any of my representatives, to bring or maintain any action against any members, officers, employees, agents or managers of the Oregon Horse Center (OHC); Horse Show Manager, Rinda Pullen and/or her employees; any representatives that coordinate and oversee the Mt. Hood Gypsy and Drum Horse Show as well as their farms, family members, any volunteers (and their family members); and any official at the show.

I agree by my signature that the released parties shall not be liable for my injury and/or death; my minor child's injury and/or death; or a minor child's (entered by a non-family member with agreement of a parent) injury and/or death; any damage or theft of my property; including injury and/or death of my horse; contraction of any communicable disease, including Covid-19; and any mental anguish.

The Equine Inherent Risk Laws in the State of Oregon 30.691, Limitations of Liability; exceptions in subsection (2); and ORS 30.693 subsection (2) of Section 2, apply.

Facility policy: If a horse, tack, or any other items are put into an empty stall, I agree to pay a minimum of \$35 for the use of that stall. All stalls used by horses must be bedded with shavings purchased from OHC . Any stall found to have outside shavings will be charged \$35. All temporary attachments (nails, staples, hooks, etc.) must be removed upon departure. No garbage is to be put into the manure pile, and all manure must be picked up in the parking lot. Dogs are allowed on leash only. If found off leash, there is a fine of \$10, a second offense will result in the dog having to be removed from the premises. Dog feces found on the grounds will result in a charge of \$10 per incident. No smoking is allowed in the buildings. No horses are allowed on the grass or in other areas designated as for boarder use only. Any property left behind after the event will become the sole property of the OHC, and the OHC will have the right to dispose of it as they see fit.

I agree to follow CDC, state, local, and facility COVID-19 regulations regarding social distancing, wearing masks, and any other requirements that may be in force during the duration of the event.
